If your defense is support by witnesses, account books, receipts or other documents, you must produce them at trial. Subpoenas for any witnesses, if request by a party, will be issued by the Clerk. If you have a claim for relief against the Plaintiff arising from the same transaction or occurrence, you must assert it in this case.

The Defendant has a right to a jury trial, however, that right is waived unless a jury trial is requested within ten (10) days after receipt of this notice of claim; that once a jury trial request has been granted, it may not be withdrawn without the consent of the other party or parties; and within ten (10) days after the jury trial has been granted, the party requesting a jury trial shall pay the Clerk the additional amount required by statue to transfer the claim to the plenary docket or , in the appropriate court of the county; otherwise, the party requesting a jury trial shall be deemed to have waived said request.
